## ENERGY EFFICIENCY

*The best kind of energy is the one not wasted. That is why we follow the EU's principle of Energy Efficiency First! We focus on energy renovations, energy standards and management, and green public procurement to achieve our goal.*



## JUST TRANSITION

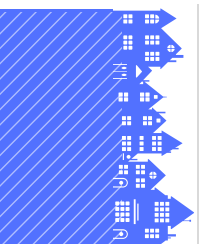
*Climate change doesn't affect all of us equally. Hence, for our vision for the future we leave no one behind. A just transition means green jobs, social inclusion, and participatory processes to democratise decision-making.*

## MOBILITY

*Transport is the single most polluting sector in Cyprus, being its greatest contributor to GHG emissions. Our modal system's reliance on fossil fuels has grave impacts on our health, while the sheer volume of cars in the streets is leading us directly to a future of gridlocks. Through planning and green technologies, we move towards accessible and clean transport for all.*

## ENERGY COMMUNITIES

*With the adoption of the "Clean Energy for All Europeans" package, we expect Energy Communities to start being formed in Cyprus as well. This is a great step towards sustainability, as Energy Communities allow for energy sovereignty at the local level, increasing citizens' access, RES penetration, and innovation.*



*Energy supply and generation is a particularly challenging task for isolated islands. However, it is already possible to fully transition to renewables. Working on the rapidly advancing **storage** solutions in combination with RES, we can make a **100% Renewables Cyprus** possible.*

## RENEWABLES

*On June 8th, 2018, Cyprus had reached its Overshoot day; the day when, if everyone lived the way we do, we would have used up all the resources the planet could replenish in a year. To ensure that future generations will be able to meet their needs, we have to manage our resource usage to keep within planetary boundaries.*
